David J. Habib, Jr., is a graduate of Southwestern University School of Law, Los Angeles, where his academic concentration was corporate and international business law. In this capacity, he negotiated, prepared and monitored execution of agreements concerning more than \$100 million in U.S. goods and services exported to public and private entities in the Middle and Far East, Europe, Africa, China, and Mexico.

In 1997, Mr. Habib entered private practice, where he represents U.S. and foreign clients in connection with a wide range of corporate, commercial, real property, and international trade related matters, including agent, distributor and joint venture relationships, technology licensing, and compliance with the F.C.P.A. and U.S. export controls, as well as in International Commercial Arbitration proceedings and complex litigation in state and federal courts. Mr. Habib is Adjunct Professor of International Business Law at Santa Barbara City College, has chaired a California State Bar approved MCLE program on the Legal Aspects of International Trade, and is former Instructor in International Trade & Risk Management for the University of California, Santa Barbara, Extension Program (Marketing & Finance).
