David J. Habib, Jr., is a graduate of Southwestern University School of Law, Los Angeles, where his academic concentration was corporate and international business law. While at Southwestern, he attained the Dean's List and graduated as a member of the Law Review. Upon graduation, he was awarded an honorary position at the Office of the Administrative Assistant to the Chief Justice, United States Supreme Court, Washington, D.C. He was first published as co-author of "*Some Comments on the Law of Separate Corporate Identity*", in Volume 1, No. 1, of the Delaware Journal of Corporate Law.

Following his assignment at the U.S. Supreme Court, Mr. Habib served for several years as Staff Counsel for the Arabian American Oil Company (now "Saudi Aramco"), a consortium of major U.S. oil companies and the Saudi Arabian Government, living and working in Houston, TX, The Hague, Netherlands, and Dhahran, Saudi Arabia. At Saudi Aramco, he assumed legal responsibility for billions of dollars worth of construction and development projects, the company's worldwide procurement activities, and its compliance with U.S. and foreign regulatory schemes. He subsequently spent several years as team leader with a consortium of international trading and project development companies, managing over \$100 million in U.S. export transactions, including over 100 aerospace supply contracts to the Chinese government. He has personally designed risk-managed, market entry structures for American companies engaged in or pursuing projects with public (i.e., government) and private parties in the Middle and Far East, Europe, Africa, China, and Mexico, creating U.S. and foreign operating entities, negotiating and writing a wide range of commercial agreements, and personally overseeing execution of numerous trading, investment and development projects.

Mr. Habib entered private practice in 1997, and maintains offices in Westlake Village, California. His practice includes representation of U.S. and foreign clients in connection with a wide range of commercial and international trade related matters, as well as in International Commercial Arbitration and Mediation proceedings and complex litigation in state and federal courts. He has completed extensive mediation training and is a certified mediator for the Ventura County Superior Courts. Mr. Habib is Adjunct Professor of Law for Business Executives in the MBA Program at California Lutheran University, taught International Business Law at Santa Barbara City College for several years, and is former Instructor in International Trade & Risk Management for the University of California, Santa Barbara, Extension Program in Management.. He has chaired a California State Bar approved MCLE program on the Legal Aspects of International Trade. He is a member of the California State Bar, the Los Angeles County Bar Association, the San Fernando Valley Bar Association, and the Arab-American Lawyers Association of Southern California, as well as the International Trade Council (Brussels). He has been appointed by successive U.S. Secretaries of Commerce to the District Export Council of Southern California (www.decsocal.org), and is currently Vice Chair. Mr. Habib is a recipient of the World Trade Centers Association World Trade Service Award, and is a sought after speaker on matters related to international trade.
